- 7 1. The Judicial Conference has prescribed fees for electronic access to court data, as
8 stated in Item (I) of the Electronic Public Access Fee Schedule (effective September 18,
9 2007). The fee for electronic access to court data via a federal judiciary Internet site is
10 \$.08 per page and applies to court data viewed remotely from the public records of
11 individual cases in the court, including filed documents and the docket.
12 2. Consistent with Judicial Conference policy, courts may, upon a showing of cause,
13 exempt indigents, bankruptcy case trustees, individual researchers associated with
14 educational institutions, courts, section 501 (c)(3) not-for-profit organizations, court
15 appointed *pro bono* attorneys, and *pro bono* ADR neutrals from payment of these fees.

27 a. A bankruptcy case trustee.
28 b. A court assigned Resolution Advocate under the U.S. Bankruptcy Court for the
Eastern District of California's Alternative Dispute Resolution (ADR) Program.

1 5. Payment of electronic public access fees by Movant in the performance of his/her duties
2 as a case trustee or Resolution Advocate would impose a financial burden upon
3 Movant.

4 6. Movant understands that any exemption from payment of electronic public access fees
5 granted as a result of this motion is only for access related to the purpose for which it
6 is given, and agrees to use his/her fee exempt account only in connection with the
7 performance of his/her duties as a case trustee or Resolution Advocate. Movant agrees
8 to make arrangements to establish a billable account with the PACER Service Center
9 for access not related to performance of his/her duties as a case trustee or Resolution
10 Advocate, and understands that it will be responsible for using the appropriate account.

11 7. Movant agrees not to sell for profit, transfer, or otherwise provide data, dockets, reports,
12 or documents obtained using its fee exempt account to third parties.

13 8. Movant understands that an exemption from payment of electronic public access fees
14 may be revoked at any time at the Court's discretion.

15 **WHEREFORE**, Movant prays for an order exempting him/her from payment of the
16 electronic public access fees prescribed by Item (I) of the Electronic Public Access Fee
17 Schedule for a period of 12 months.
