Position Overview

The successful candidate will serve as law clerk to the Honorable Chief Judge Ronald H. Sargis. Judicial law clerks are primarily responsible for legal research and the preparation of orders, memoranda, and draft opinions. This position includes the management of externs, oversight of their workload and court experience. A demonstrated interest in bankruptcy law is preferred. This position is located in Sacramento, California, and is for a **two-year term**.

Minimum Qualifications

To qualify for this position, you must be a law school graduate with academic standing within the upper quarter of the class. Applicants must possess excellent research, analytical, writing and communications skills, and PC proficiency.
