### PROOF OF IDENTITY AND SOCIAL SECURITY NUMBER

Individual debtors must provide proof of their identity and Social Security number to the trustee or the United States Trustee's representative at the meeting of creditors held pursuant to §341(a) of the Bankruptcy Code. The meeting of creditors will be continued, or dismissal sought, if the debtor fails to provide acceptable proof of identity and Social Security number.

#### A. **PROOF OF IDENTITY**

The forms of **GOVERNMENT ISSUED PHOTO IDENTIFICATION** listed below will be accepted by the trustee and the United States Trustee's representative as proof of identity. The name on the photo identification must match the debtor's name or an alias (aka) stated on the petition.

- 1. Valid state driver's license
- 2. Any government-issued photo I.D. card \*
- 3. Official passport from any country
- 4. Government employee photo I.D. card
- 5. Military photo I.D. card
- 6. Legal resident alien card with photo
- \* Although Matricula cards issued by the Mexican Embassy will be accepted by the trustee and the United States Trustee's representative as proof of identity for bankruptcy purposes, they may not be accepted by court security officers as proof of identity when entering the courthouse.

### B. PROOF OF SOCIAL SECURITY NUMBER

The items listed below will be accepted by the trustee and the United States Trustee's representative as proof of Social Security number.

- 1. Social Security card (original card only not a copy)
- 2. Statement from the Social Security Administration verifying the number
- 3. Military I.D. card \* \*
- Medicare card \* \*
- \* \* Military I.D. cards and Medicare cards will be accepted only if they provide the full Social Security number.

ALL ITEMS OF PROOF (INCLUDING SOCIAL SECURITY CARDS) MUST BE ORIGINALS.
COPIES WILL NOT BE ACCEPTED.
