3 **ORDER GRANTING EXEMPTION FROM PAYMENT OF THE ELECTRONIC**
4 **PUBLIC ACCESS USER FEE IMPOSED BY ITEM (I) OF THE**
5 **ELECTRONIC PUBLIC ACCESS MISCELLANEOUS FEE SCHEDULE TO:**

8 This matter is before the Court on the motion of _____
9 for exemption from payment of the electronic public access user fee imposed by Item
10 (I) of the Electronic Public Access fee schedule adopted by the Judicial Conference of
11 the United States Courts.

12 The Court finds that _____ as a bankruptcy case
13 trustee, individual researcher, or resolution advocate falls within the class of users listed
14 in the fee schedule as being eligible for a fee exemption. Additionally, the Court finds
15 that _____ has demonstrated that an exemption is necessary
16 in order to avoid unreasonable burdens and to promote public access to information.
17 Accordingly,

18 **IT IS ORDERED** that _____ shall be exempt from
19 the payment of fees for access via PACER to the electronic case files maintained in this
20 court, to the extent such use is incurred in the course of the performance of his/her
21 duties as a bankruptcy case trustee, individual researcher, or resolution advocate.
22 He/she shall not be exempt from the payment of fees incurred in connection with other
23 uses of the PACER system in this court. Additionally, the following limitations apply:

- 24 1. This fee exemption applies only to _____ and is
25 valid only for the purpose stated above;
- 26 2. This fee exemption applies only to the electronic case files of this court that are
27 available through the PACER system;
- 28 3. By accepting this exemption, _____ agrees not
to sell for profit any data, dockets, reports, or documents obtained as a result of

1 receiving this exemption;

2 4. _____ is prohibited from transferring or otherwise
3 providing to third parties any data, dockets, reports, or documents data obtained
4 as a result of receiving this exemption; and

5 5. This exemption is valid for for the period _____ to _____ .

6 **IT IS FURTHER ORDERED** that _____ shall make
7 arrangements to establish a billable account with the PACER Service Center for access
8 not related to performance of his/her duties as a bankruptcy case trustee, individual
9 researcher or resolution advocate and shall be responsible for using the appropriate
10 account. In addition to a fee exempt account, the PACER Service Center shall
11 establish a billable account to be used by _____ in
12 connection with access unrelated to the performance of his/her duties as a bankruptcy
13 case trustee, individual researcher or resolution advocate.

14 This exemption may be revoked at the discretion of the Court at any time. The
15 Clerk of Court, or the Clerk's designee, shall provide copies of this order to the PACER
16 Service Center and to _____.
