
11 For the reasons stated in this court's Opinion filed July

13 IT IS ORDERED that no party, person, or entity may disclose,
14 without the prior permission of this court, any statements made,
15 information disclosed, or documents produced during the neutral
16 evaluation process that was conducted before the filing of this
17 case pursuant to California Government Code § 53760.3.

18 IT IS FURTHER ORDERED, with respect to mediation that may
19 occur during this case, that no party, person, or entity may
20 disclose, without the prior permission of this court, any
21 statements made in the course of the mediation or documents
22 prepared for purpose of the mediation.

23 IT IS FURTHER ORDERED that the City of Stockton may disclose
24 its 790-page so-called "ask" presented during the pre-filing
25 neutral evaluation.
