Format of Documents

Documents that are submitted at our front counters at our offices in Sacramento, Modesto or Fresno, or through the mail, should be printed on 8 ½ x 11 inch white paper. Original documents should be printed on one side and should not be stapled or hole punched, as they will be scanned after filing.

Obtaining Forms

Forms for filing bankruptcy can be obtained on our website at www.caeb.uscourts.gov and at the front counters of each divisional office. There is no charge to print forms from our website; there will be a fee charged for forms packages at our front counters.

Individual and Non-Individual Forms

Forms for individuals (including joint petitions) should be filed on petition forms in the 100 series. Forms for non-individuals (businesses and other entities) should be filed using petition forms in the 200 series.

Assembly of Documents

Do not attach the master address list, verification of master address list form, statement of social security number(s), initial statement about an Eviction Judgment, Chapter 12 Debtor's Plan or Chapter 13 Debtor's Plan to the petition.

Documents that may be attached to the plan include Schedules A – J and declarations regarding schedules, Summary of Schedules, Statement of Current Monthly Income, Statement of Financial Affairs, Statement of Intention, and Certificate of Completion of Credit Counseling Briefing.

Copies

If filing documents at our front counters or through the mail, please provide the original and one copy of each document as well as a self-addressed stamped envelope that is large enough and has enough postage to return your copies.

Accepted Fee Payment Methods

Filing fees must be paid in person or by mail with money order, cashier's check, or an attorney's check. All money orders and checks must be made payable to: Clerk, U.S. Bankruptcy Court. Debit cards are also accepted in person at our Sacramento, Modesto, and Fresno offices. Registered users of our e-Filing system must pay for items requiring a fee through the pay.gov system. Debtors may use our Online Installment to pay court approved filing fee installments payments. No cash accepted.

Master Address List

<u>Debtors not represented by an attorney, or whose petitions are prepared by a Bankruptcy Petition</u>
<u>Preparer, must prepare the Master Address List using one of the following methods:</u>

- In hard copy format, following the guidelines described in Guidelines re; Master Address List.
- In hard copy format, using the court's online application available at www.caeb.uscourts.gov/mal/. This guided process will help you complete the address list in the correct format and generate the required verification.

• In electronic format when submitting their petition online through the court's Debtor Drop Box program available at www.debtordropbox.caeb.uscourts.gov. This system will format your address list and electronically produce your required verification.

Attorneys must prepare an electronic version of the Master Address List for direct submission through the court's electronic filing system. The Master Address List must be saved in a text format (not delimited) with a .txt extension.
