The Chapter 13 Trustee seeks dismissal of Debtor's case based on the following:

- A. Debtor is \$3,520.00 delinquent in plan payments to the Trustee to date with another monthly payment of \$430.00 to become due prior to this hearing. Debtor has paid \$24,510.00 into the plan to date.

Debtor's Opposition

Debtors admit they are behind in payments and request that the hearing be continued to after November 25, 2016 in order to catchup on plan payments as November is the final month of the plan.

Trustee's Reply

Trustee had no opposition to the continuance of the hearing on this motion until after November 25, 2016.

Discussion

The motion was continued from October 12, 2016. The court has no evidence that the debtors are current on plan payments. As a result, the motion to dismiss will be granted.

Tentative Ruling: Oral argument may be presented by the parties at the scheduled hearing, where the parties shall address the issues identified in this tentative ruling and such other issues as are necessary and appropriate to the court's resolution of the matter. If the court's tentative ruling becomes its final ruling, the court will make the following findings of fact and conclusions of law:

The Order to Show Cause was served by the Clerk of the Court on the Debtor Trustee, and other such other parties in interest as stated on the Certificate of Service on March 14, 2017.

The court issued an Order to Show Cause based on Debtor's failure to pay the required fees in this case (\$77.00 due on March 9, 2017).

The court's decision is to sustain the Order to Show Cause.

The court's docket reflects that the default in payment which is the subjection of the Order to Show Cause has not been cured. The following filing fees are delinquent and unpaid by Debtor: \$77.00.

The court shall issue a minute order substantially in the following form holding that:
