**Final ruling:**

**This is the debtors' motion to value collateral of One Main Financial; namely, a motor vehicle. The motion will be denied for the following reasons: (1) the notice of hearing states that the hearing will be held in Sacramento whereas this is a calendar for Modesto cases; nothing in the other moving papers indicates the hearing is to be held in Modesto; and (2) there is nothing in the moving papers or the debtors' schedules from which the court can determine when the debt was incurred or whether the debt is secured by a purchase money security interest. Thus, the court cannot determine whether the claim falls within the scope of the "hanging paragraph" of § 1325(a). Where required on Schedule B to indicate the date the debt was incurred, the debtors failed to do so. The creditor has not filed a proof of claim, so the court cannot obtain the relevant information from a proof of claim.**

**As a result of these notice and evidentiary defects, the motion will be denied by minute order. No appearance is necessary.**
