MOTION TO MODIFY PLAN 11-1-18 [119]

Tentative ruling:

This is the debtor's motion to confirm a modified chapter 13 plan. The motion will be denied because the moving party failed to serve the current holders of two secured claims, Claim Nos. 3 and 5, in the amounts of \$248,764 and \$18,532. Instead, the moving party served the original holders of the claims. The transfers of claim appear on the court's docket as DNs 113 and 114, and the names and addresses of the current claim holders appear on the court's claims register. Both transfers of claim were filed months before this motion was filed and served. By failing to serve the current holders of these claims, the moving party failed to serve all creditors, as required by Fed. R. Bankr. P. 2002(a)(9).

As a result of this service defect, the motion will be denied by minute order. Alternatively, the court will continue the hearing to allow the moving party to cure this service defect.

Tentative ruling:

This is the debtors' amended motion to extend the automatic stay. The case was commenced on October 26, 2018; the 30th day after that date was November 25, 2018. The hearing on the motion is set for December 11, 2018. Thus, the motion will be denied because the hearing will not be completed within the 30 days following the commencement of the case, as required by § 362(c)(3)(B) of the Bankruptcy Code.

The court is aware the debtors filed an earlier motion, on November 16, 2018, which they attempted to set for hearing on December 18, 2018, which is also a date that is after the end of the 30-day period. The clerk's office notified the debtors' counsel that was not a correct date for the hearing (it is a date for hearings in Modesto Division cases), and informed counsel that the motion would be calendared only upon receipt of an amended notice of hearing with a hearing date of either December 11, 2018 or January 8, 2019. The clerk's notice was not an implicit suggestion that the court would permit the debtors to re-schedule the hearing for a correct date or, in order to do so, suspend the operation of the 30-day requirement. It was merely a notice that the debtors had selected an incorrect date for the hearing, which, in any event, was itself beyond the 30-day deadline.

The court will hear the matter.
