

**United States Bankruptcy Court

AMENDED SEPTEMBER - OCTOBER 2020

Hearings on all matters arising in cases or adversary proceedings assigned to Department A or Department B of the Fresno Division of this bankruptcy court shall be heard on the dates and at the times set forth below. All hearings shall be "self-set" by the party requesting the order for which a hearing is required.

Without regard to the county of origin of the case and without court order, all matters in cases or related adversary proceedings may be set either (1) in Fresno at 2500 Tulare Street, 5th Floor, Fresno, California, in Courtroom 11 for Department A matters and in Courtroom 13 for Department B matters, or (2) in Bakersfield at 510 19th Street, Bakersfield, California, for Department A or B matters.

All matters filed and set for hearing, and their supporting papers, shall comply with applicable provisions of the Federal Rules of Bankruptcy Procedure and this court's Local Rules of Practice for the United States Bankruptcy Court, Eastern District of California ("LBR").

Telephonic appearances may be arranged by contacting Court Call at (866) 582-6878 no later than 24 hours before the scheduled hearing. Whether a party may appear telephonically on a particular matter is determined by the rules applicable to telephonic appearances, which may be found under the "Telephone Appearances" link under the "Calendar/Transcripts" heading, located in the right column of the homepage of the Bankruptcy Court Eastern District of California's website (www.caeb.uscourts.gov).

On the day before the court's calendar of hearings, the court releases "Pre-Hearing Dispositions" for many matters on the calendar for which the court found a pre-hearing disposition preferable. Pre-Hearing Dispositions are available (1) the morning of the hearing outside the courtroom or on counsels' table at the applicable location for the hearing as described above; or (2) the day prior to the hearing on the court's website (www.caeb.uscourts.gov) by following the "Pre-Hearing Dispositions" link under "Calendar/Transcripts" heading in the right column of the homepage of the website <http://www.caeb.uscourts.gov>). Instructions found on the cover page of the Pre-Hearing Dispositions and the applicable ruling should be reviewed prior to the hearing.
