**NOTICE CONCERNING BANKRUPTCY COURT MISCELLANEOUS FEE SCHEDULE
INCREASES EFFECTIVE NOVEMBER 1, 2011**

At its September 2011 session, the Judicial Conference of the United States approved inflationary increases to certain miscellaneous fees for federal courts effective November 1, 2011. The increased amounts for bankruptcy court miscellaneous fees are set forth below.
