Overview

The US Bankruptcy Court would like to upgrade DSP (Digital Sound Processor) and Control System in three Court Rooms.

The DSP upgrade will include the transition of the Telephone connection from analog to digital (VOIP).

The Control Upgrade will include transition from AMX to Crestron

Scope of Work / System Description

Audio System

DSP Output Count

The DSP units shall have (9) outputs. Rooms will have outputs as follows:

- 1) Courtroom Speakers
- 2) Assistive Listening Systems
- 3) Office Speakers (unknow where these are or if they are being used)
- 4) Codec Send (for rooms with Video Conference Systems)
- 5) Court Smart Recorder Input 1
- 6) Court Smart Recorder Input 2
- 7) Court Smart Recorder Input 3
- 8) Court Smart Recorder Input 4
- 9) Court Smart Recorder Input 5

DSP Model and Scope

Replace the Biamp Audia processor with a current generation model Biamp TesiraForte VT. This will have the added advantage of both an analog and a VOIP telephone interface. Configure For VOIP.

Configure the Forte to perform the same functions as the existing Audia including live audio, recorded audio and telephone interconnection. Add Conferencing Transmit controls on a special advanced page. Fine tune the levels in each room including the Assistive Listening System. Provide a VOIP configuration worksheet which we will fill in with the parameters of the VOIP connection.

For rooms with VTC, include the option for a system that is expandable, and includes a module with (4) more outputs so it can provide a ninth output.

Control System

Replace the AMX Control Processor and Touch Panel with a Crestron AV3 Control Processor and a Black TSW-1060 Touch Panel with Tabletop Kit. Link the TesiraForte to the Crestron Control System. Update the

Control System to "talk" to the new Forte Processor.

Provide a web accessible GUI to allow a Clerk or administrator to remotely log into the system via your VP and control the Touch Panel functions remotely.

Existing Rack and Cabling

Reuse the existing rack and all cable from the system including the cables from the microphones, to the amplifier and Assistive Listening System, and cables to the recording PC.
