## Frequently Asked Questions

- **Q:** Which hearings have audio files on PACER?
- A: Bankruptcy judges have discretion on which audio recordings, if any, will be available on PACER.
- **<u>Q</u>:** How do I know if the docket entry contains an audio file?
- <u>A:</u> The docket entry contains the following language at the beginning of the entry: **PDF with attached audio file**. Example of docket text:

- **Q:** How do I get the audio recording to play?
- <u>A:</u> Your internet browser determines the method needed to play the recording. This guide contains instructions for downloading the file in Chrome, Firefox, and Microsoft Edge. It also contains instructions for listening to the audio file once you have opened the downloaded PDF in Adobe.
- **Q:** How much does it cost to listen to an audio file?
- <u>A:</u> Users may access the digital recordings through PACER for a flat rate of \$2.40 per matter. Parties to a case are eligible to access the digital recording at no charge as their initial free look. The initial free review expires in 90 days, however, the files can be downloaded to your computer and accessed at your convenience.
- **Q:** How can I save the audio file to my computer?
- <u>A:</u> Before you open the audio file, you can right click on the file and select **Save Attachment**. If you have already opened the file in Windows Media Player, switch to the Library mode, located on the upper right corner of the audio file. Click to **Save List** located on the right upper corner.

- **Q:** Can I have the digital audio file of a court hearing on PACER transcribed?
- <u>A:</u> No, audio files that have been docketed and are available on PACER are not considered the official record and cannot be used to make official transcripts.

Select whether you want to **Open with Adobe Acrobat** or **Save the File** and click **OK**. If you open the file with Adobe, you will be able to listen the audio file immediately, but the file will not be saved unless you do so before closing it. If you choose to save the file, you will need to reopen it in Adobe to listen to the attached audio file.

Click the paper clip icon circled above. This will open the attachment to the PDF:



Click on the name of the attachment as circled above. This will open your computer's audio player and play the audio file of the court hearing.

**NOTE:** If you are unable to download the audio file, or you download the file but it gives you an error or won't save the file as a PDF, first clear your cache. To do this, go to your browser settings. Under **Privacy and Security**, click **Clear browsing data**, and then select the box next to **Cached images and files**. Click the **Clear data** button. Return to your browser and try downloading the file again.
