- Click on **By Date** to return to the default setting of searching by date.

If searching by date (default setting) you will see a chronological list of calendar dates. When you find your date, click on the View hyperlink, which will display that day's calendar.

When you find your matter, click on the **ZoomGov Sign Up** link.
