Recent Judicial Transitions in the Eastern District of California

Judge Clement Moves to Sacramento Division

Judge Fredrick E. Clement moved to Sacramento in August 2019. Judge Clement will hear matters in Sacramento, Department A, Courtroom 28. Judge Clement will also hear matters in Fresno, Department A until a new judge takes the bench in Fresno.

Judge Retirement

Judge Robert S. Bardwil retired on August 7, 2019. Judge Bardwil was appointed to the bench in 2005. He heard cases in Department D in both the Sacramento and Modesto divisions. He will continue to hear matters as a recall judge through December.

Information Regarding Redaction of Social Security Numbers

When filing a new petition, or new or amended schedules, please remember to redact all sensitive information such as social security numbers.

The court does require the full social security number for debtors, but restricts the image of the Social Security Statement (Official Form B121) so that the form can only be viewed by court personnel. In order to ensure that this sensitive information is not available to the public, please submit the Social Security Statement as a separate document.
