ORDER DENYING APPLICATION TO AUTHORIZE REPRESENTATIVE FILING AND TO WAIVE ELIGIBILITY REQUIREMENTS FOR BARNEY F. INGRAM

This order is in response to a document filed ex parte in this case entitled Declaration of Shirley Ingram regarding: 1. Authority to file on behalf of Barney F. Ingram, Jr., and 2. Lack of payment advices (the "Ex Parte Application"). Ms. Ingram requests that the court (1) waive the eligibility requirement under 11 U.S.C. § 109(h)(1) for Barney Ingram because he is allegedly "incompetent." The Ex Parte Application will be denied for the following reasons: (1) This court has the authority under 11 U.S.C. § 109(h)(4) to waive the eligibility requirement in § 109(h)(1) based on, inter alia, the debtor's incapacity or disability. However, there is no evidence before this court that Barney Ingram has been adjudicated to be incompetent to manage his estate by a court of proper jurisdiction, (2) Attached to the Ex Parte Application is a copy of Letters of Conservatorship for Barney Ingram issued by the Tulare County Superior Court on August 16, 2000. The Letters of Conservatorship give Shirley Ingram powers as Conservator of the Person for Barney Ingram. Ms. Ingram has not been appointed as Conservator of the Estate for Barney Ingram, As such, there is no evidence that Shirley Ingram has authority to file this bankruptcy petition on behalf of Barney Ingram; and (3) This bankruptcy petition was filed by Barney Ingram in his own name. It was not filed by Shirley Ingram in any representative capacity for Barney Ingram. The bankruptcy petition itself makes no mention of that Shirley Ingram is filing for Barney Ingram in a representative capacity.

1	Based on the foregoing, the Ex Parte Application to Authorize Shirley Ingram to
2	file this bankruptcy petition for Barney Ingram, and to waive the eligibility requirement
3	for Barney Ingram under 11 U.S.C. § 109(h)(1) is DENIED.
