If no opposition is offered at the hearing, the court will take up the merits of the objection. Below is the court's tentative ruling, rendered on the assumption that there will be no opposition. The objection will be sustained and the motion to dismiss the case will be conditionally denied.

First, the plan fails to provide at section 2.07 for a dividend to be on account of allowed administrative expenses, including the debtor's attorney's fees. Unless counsel is working for nothing, this means that the plan does not provide for payment in full of priority claims as required by 11 U.S.C. § 1322(a)(2). Also see 11 U.S.C. §§ 503(b), 507(a).

Second, the plan is not feasible as required by 11 U.S.C. § 1325(a)(6) because the monthly plan payment of \$4,000 is less than the \$4,984 in dividends and expenses the plan requires the trustee to pay each month.

Third, the plan misclassifies a nonpriority unsecured claim as a secured claim. This means that the misclassified claim will be paid in full while other unsecured claims will not be paid in full. This is an unfair discrimination. See 11 U.S.C. § 1322(b)(1).

Because the plan proposed by the debtor is not confirmable, the debtor will be given a further opportunity to confirm a plan. But, if the debtor is unable to confirm a plan within a reasonable period of time, the court concludes that the prejudice to creditors will be prejudicial and that there will then be cause for dismissal. If the debtor has not confirmed a plan within 75 days, the case will be dismissed on the trustee's ex parte application.

To attempt to confirm a plan while withholding relevant financial information from the trustee is bad faith. See 11 U.S.C. § 1325(a)(3).

Second, the debtor has failed to list all income on Form 22 when calculating current monthly income. This has resulted in the debtor failing to complete the portion of the form that calculates projected disposable income as an overmedian income debtor. The failure to accurately and completely complete Form 22 is a breach of the duties imposed by 11 U.S.C. § 521(a)(1), (3), and (4). To attempt to confirm a plan while withholding relevant financial information from the trustee is bad faith. See 11 U.S.C. § 1325(a)(3).

Third, because the debtor's exemptions will likely be disallowed, the plan does not comply with 11 U.S.C. § 1325(a)(4). Unsecured creditors would receive more than 37,000 in a chapter 7 liquidation as of the effective date of the plan. This plan will pay nothing to unsecured creditors.

Because the plan proposed by the debtor is not confirmable, the debtor will be given a further opportunity to confirm a plan. Tentative Ruling: The motion will be granted.

This is the second chapter 13 case filed by the debtor in the prior year. The first case was dismissed within the last year.

11 U.S.C. § 362(c)(3)(A) provides that if a single or joint case is filed by or against a debtor who is an individual in a case under chapter 7, 11, or 13, and if a single or joint case of the debtor was pending within the preceding oneyear period but was dismissed, the automatic stay with respect to a debt, property securing such debt, or any lease terminates on the 30^{th} day after the filing of the new case.

Section 362(c)(3)(B) allows a debtor to file a motion requesting the continuation of the stay. A review of the docket reveals that the debtor has filed this motion to extend the automatic stay but was unable to bring it to hearing before the 30^{th} day after the filing of the petition.

As a result, pursuant to section 362(j) the court confirms the absence of the automatic stay. And, based on the bankruptcy appellate panel's <u>Reswick</u> decision, the court confirms the absence of the automatic stay as to both the debtor and the bankruptcy estate. <u>See In re Reswick</u>, 446 B.R. 362 (9th Cir. BAP 2011). Whether or not this authority is binding on this court, the court considers it persuasive.

Independent of relief under section 362(j), there are grounds for terminating the automatic stay if it exists.

At a hearing on December 30, the court denied confirmation of the debtor's proposed plan. No modified plan has been proposed.

Second, the collateral for the movant's claim, rental property in Oakland, is over-encumbered as is evident from a review of Schedule D. And, there is no convincing evidence with the opposition to the motion that the rental property is necessary to this reorganization.

Even assuming the automatic stay remains in place as to the estate, Reswick

notwithstanding, the court would terminate the automatic stay pursuant to 11 U.S.C. § 362(d)(1) and (d)(2). There is no equity in the property and the debtor has failed to carry the burden of demonstrating the properties necessity to a reorganization. Further, no reorganization is in prospect.

Upon plan completion, both debtors shall receive a discharge.

Tentative Ruling: The motion will be denied.

The case was dismissed as a result of the trustee's notice of default. This procedure, as authorized by Local Bankruptcy Rule 3015-1(g), which provides:

(1) If the debtor fails to make a payment pursuant to a confirmed plan, including a direct payment to a creditor, the trustee may mail to the debtor and the debtor's attorney written notice of the default.

(2) If the debtor believes that the default noticed by the trustee does not exist, the debtor shall set a hearing within twenty-eight (28) days of the mailing of the notice of default and give at least fourteen (14) days' notice of the hearing to the trustee pursuant to LBR 9014-1(f)(2). At the hearing, if the trustee demonstrates that the debtor has failed to make a payment required by the confirmed plan, and if the debtor fails to rebut the trustee's evidence, the case shall be dismissed at the hearing.

(3) Alternatively, the debtor may acknowledge that the plan payment(s) has(have) not been made and, within thirty (30) days of the mailing of the notice of default, either (A) make the delinquent plan payment(s) and all subsequent plan payments that have fallen due, or (B) file a modified plan and a motion to confirm the modified plan. If the debtor's financial condition has materially changed, amended Schedules I and J shall be filed and served with the motion to modify the chapter 13 plan.

(4) If the debtor fails to set a hearing on the trustee's notice, or cure the default by payment, or file a proposed modified chapter 13 plan and motion, or perform the modified chapter 13 plan pending its approval, or obtain approval of the modified chapter 13 plan, all within the time constraints set out above, the case shall be dismissed without a hearing on the trustee's application.

Thus, a debtor receiving a Notice of Default has three alternatives: (1) Cure the default within 30 days of the notice of default; (2) within 30 days of the notice of default, file a motion to confirm a modified plan and a modified plan in order to cure/suspend the default stated in the notice of default; or (3) contest the notice of default by setting a hearing within 28 days of the notice of default on 14 days of notice to the trustee.

In this case, the debtor exercised the second alternative - the debtor proposed a modified plan to resolve the plan default. That modified plan and a motion to confirm it were filed timely under the local rule. However, the court denied the motion and the debtor failed to obtain an extension of time to confirm a plan or to otherwise cure the default under the confirmed plan. As a result, the trustee sought and obtained the dismissal of the case. This motion fails to demonstrate excusable neglect in connection with the failure to confirm the modified plan or to obtain an extension of time before the original time period to confirm a modified plan expired.

If no opposition is offered at the hearing, the court will take up the merits of the objection. Below is the court's tentative ruling, rendered on the assumption that there will be no opposition. Obviously, if there is opposition, the court may reconsider this tentative ruling.

The objection will be sustained.

11 U.S.C. § 109(h) prohibits an individual from being a debtor under any chapter unless that individual received a credit counseling briefing from an approved non-profit budget and credit counseling agency before the petition is filed. In this case, the certificate evidencing that briefing indicates that it was received after, not before, the petition was filed. Hence, the debtor was not eligible for bankruptcy relief when this petition was filed. It is unnecessary to address the remaining objections.

Tentative Ruling: Because less than 28 days' notice of the hearing was given by the debtor, this motion is deemed brought pursuant to Local Bankruptcy Rule 9014-1(f)(2). Consequently, the creditors, the trustee, the U.S. Trustee, and any other parties in interest were not required to file a written response or opposition to the motion. If any of these potential respondents appear at the hearing and offers opposition to the motion, the court will set a briefing schedule and a final hearing unless there is no need to develop the record further. If no opposition is offered at the hearing, the court will take up the merits of the motion. Below is the court's tentative ruling, rendered on the assumption that there will be no opposition to the motion. Obviously, if there is opposition, the court may reconsider this tentative ruling.

The motion will be granted.

This is the second chapter 13 case filed by the debtor. A prior case was dismissed with the prior year because the debtor to maintain plan payments.

11 U.S.C. § 362(c)(3)(A) provides that if a single or joint case is filed by or against a debtor who is an individual in a case under chapter 7, 11, or 13, and if a single or joint case of the debtor was pending within the preceding oneyear period but was dismissed, the automatic stay with respect to a debt, property securing such debt, or any lease terminates on the 30^{th} day after the filing of the new case.

Section 362(c)(3)(B) allows a debtor to file a motion requesting the continuation of the stay. A review of the docket reveals that the debtor has filed this motion to extend the automatic stay before the 30^{th} day after the filing of the petition. The motion will be adjudicated before the 30-day period expires.

In order to extend the automatic stay, the party seeking the relief must demonstrate that the filing of the new case was in good faith as to the creditors to be stayed. For example, in <u>In re Whitaker</u>, 341 B.R. 336, 345 (Bankr. S.D. Ga. 2006), the court held: "[T]he chief means of rebutting the presumption of bad faith requires the movant to establish 'a substantial change in the financial or personal affairs of the debtor . . . or any other reason to conclude' that the instant case will be successful. If the instant case is one under chapter 7, a discharge must now be permissible. If it is a case under chapters 11 or 13, there must be some substantial change."

Here, it appears that the debtor was unable to maintain plan payments in the first case due to a loss of employment. The debtor has found a new job and with the income of a new spouse, the debtor appears to have sufficient income to maintain plan payments. This is a sufficient change in circumstances rebut the presumption of bad faith.
