This voluntary Chapter 11 case was filed on December 1, 2020 by Alejandro C. Alejandro and Griselda Gonzalez who are now serving as the Debtor in Possession. On the Petition Debtor lists having one prior bankruptcy case in the prior eight years, that being case number 20-223983 in the Eastern District of California. Petition, ¶ 9; Dckt. 1. A review of the filed of this court discloses that in the past eight years debtor Alejandro C. Alejandro filed case 20-223983 on August 17, 2020, and which

was dismissed on August 28, 2020; and debtor Griselda Alejandro filed case 20-22585 on May 19, 2020, and which was dismissed on June 17, 2020. In these prior cases each of the debtors filed them in *pro se*. In the current case the two debtors were represented by counsel in filing the case and are represented by that counsel as the Debtor in Possession.

Debtor in Possession filed a Status Report on January 14, 2021. Dckt. 35. The two main creditors hold deeds of trust on residential real property that the Debtor in Possession intends to keep through a plan.
