Final ruling:

This is the debtor's motion to confirm an amended chapter 13 plan. The motion will be denied for the following reasons: (1) the moving papers contain the same docket control number used for an earlier motion in this case, contrary to LBR 9014-1(c); and (2) the moving party utilized an outdated service list, and therefore, failed to serve the creditors filing Claim Nos. 11 - 15 at the addresses on their proofs of claim, as required by Fed. R. Bankr. P. 2002(g). In fact, it appears the moving party failed to serve some of those creditors at all. In addition, the amended plan that is the subject of this motion is identical to the plan that was the subject of the earlier motion, a motion that was denied. In fact, at the hearing on that earlier motion, the debtor's counsel stated that the trustee's opposition (which was identical to his opposition to this motion) was well-founded. The court therefore is unable to find that the plan has been proposed in good faith.

For the reasons stated, the motion will be denied by minute order. No appearance is necessary.
