Final Ruling

The motion has been set for hearing on less than 28-days notice. Local Bankruptcy Rule 9014-1(f)(2). Parties in interest were not required to file a written response or opposition.

The court has determined that oral argument will not assist in the decision-making process or resolution of the motion. See Local Bankr. R. 9014-1(h), 1001-1(f). This matter will therefore be decided on the papers.

The court's decision is to <u>conditionally grant the motion to dismiss case and continue</u> the matter to March 1, 2022, at 1:00 p.m.

First, Debtor is delinquent \$1,800.00 as of February 7, 2022. The last payment was received on January 18, 2022. 11 U.S.C. § 1307(c)(4). This is unreasonable delay that is prejudicial to creditors. 11 U.S.C. § 1307(c)(1).

Second, a hearing on confirmation of Debtor's first amended plan was heard on January 18, 2022, and confirmation was denied. Debtor has failed to file, set, and serve an amended plan to date. This is unreasonable delay that is prejudicial to creditors. 11 U.S.C. \$ 1307(c)(1).

Cause exists to dismiss this case. The motion is conditionally granted and the case will be dismissed.

Conditional Nature of this Ruling

Because the motion has been filed, set, and served under Local Bankruptcy Rule 9014-1(f)(2), any party in interest shall have until 5:00 p.m. on <u>Friday</u>, <u>February 25, 2022</u>, to file and serve an opposition or other response to the motion. See Local Bankr. R. 9014-1(f)(2)(C). Any opposition or response shall be served on the Chapter 13 Trustee and the United States trustee by facsimile or email.

If no opposition or response is timely filed and served, the motion will be deemed granted for the reasons stated hereinabove, this ruling will no longer be conditional and will become the court's final decision, and the continued hearing on March 1, 2022, at 1:00 p.m. will be vacated.
