A review of the Certificate of Service states that in addition to the Debtor and the Office of the U.S. Trustee, it was served on an entity identified as "Stutz Law Office PC." Debtor's counsel of record in Matthew J. DeCaminada, who is identified as being an attorney with Stutz Law Office PC, however, the Certificate of Service does not state he was served - either by mail or electronically.

The Motion to Dismiss has been set for hearing on the notice required by Local Bankruptcy Rule 9014-1(f)(1). Trustee filed a Response on February 24, 2021 informing the court that Debtor has communicated that he may be receiving a gift from relatives to cure the default and requests the court not dispose of this matter by final ruling. Dckt. 45.

Unfortunately for Debtor, a promise to pay is not evidence that resolves the Motion.

Based on the foregoing, cause exists to dismiss this case. The Motion is granted, and the case is dismissed.

Unfortunately for Debtor, a promise to pay is not evidence that resolves the Motion.

Based on the foregoing, cause exists to dismiss this case. The Motion is granted, and the case is dismissed.

Sufficient Notice Provided. The Proof of Service states that the Motion and supporting pleadings were served on Debtor, Debtor’s Attorney, and Office of the United States Trustee on October 20, 2020. By the court’s calculation, 29 days’ notice was provided. 28 days’ notice is required.

The Motion to Dismiss has been set for hearing on the notice required by Local Bankruptcy Rule 9014-1(f)(1). Debtor filed opposition. If it appears at the hearing that disputed, material, factual issues remain to be resolved, then a later evidentiary hearing will be set. LOCAL BANKR. R. 9014-1(g).

The Motion to Dismiss is XXXXXX.

The Chapter 13 Trustee, David Cusick (“Trustee”), seeks dismissal of the case on the basis that the debtor, Kelvin Quentin Pickett (“Debtor”), is delinquent in plan payments and has failed to file an amended plan.

DEBTOR’S OPPOSITION

On November 3, 2020, Debtor filed an Opposition stating that a new plan will be filed prior to this hearing. Dckt. 31.

DISCUSSION

Delinquent

Debtor is \$4,080.00 delinquent in plan payments, which represents multiple months of the

\$2,040.00 plan payment. Before the hearing, another plan payment will be due. Failure to make plan payments is unreasonable delay that is prejudicial to creditors. 11 U.S.C. § 1307(c)(1).

Prior Plan Denied, New Plan and Motion Filed

Debtor filed a First Amended Plan on November 11, 2020. Dckt. 42. The Amended Plan provides for Debtor to have made a total of \$2,040 for the first four months of the Plan - only \$500 a month - and then \$2,107 for the remaining 56 months of the Plan. Plan, Add. Prov., p. 7; Dckt. 42.

The Motion to Confirm states with particularity grounds upon which confirmation is requested. Dckt. 38. The Motion states that all of Debtor's assets are exempt.

Debtor provides his Declaration in support of the Motion to Confirm the Amended Plan. Dckt. 40. Debtor's testimony does not include any testimony as to why for the first four months of the Plan the Debtor pays a discounted amount of \$500 a month and where the \$6,000 (\$1,500 a month) were diverted during the first four months of the Plan.

On Supplemental Schedule I filed on November 12, 2020, Debtor states that he is unemployed and has income of \$2,910.00 a month. Dckt. 36 at 4-5. The sources of this income are stated to be:

Rental of Property/Business.....	\$ 300

Brother.....	\$ 600	(Not on Original Schedule I)
"side jobs".....	\$ 270	(Not on Original Schedule I)

The Declaration of Ronald Pickett has been filed in support of the Motion to Confirm. In it, Ronald Pickett testifies that he has \$4,000 a month in net income, but expenses of only \$400 a month. Dckt. 34. Ronald Pickett offers no testimony as to how an adult person in the 21st Century can only have \$400 a month in expenses. Given that this declaration necessarily had to be carefully crafted by Debtor's counsel and represents the best testimony that Ronald Pickett can provide, it falls woefully short of being credible.

The second Declaration is provided by Igauna Pickett, Debtor's daughter, an adult that Debtor lists as a dependent. Dckt. 35. She testifies that her net income is approximately \$800 a month, and she has expenses of only \$150 a month. As with the Debtor's brother, Igauna Pickett offers no testimony as to how an adult in the 21st Century can have only \$150 a month in expenses. Again, given that this declaration necessarily had to be carefully crafted by Debtor's counsel and represents the best testimony that Igauna Pickett can provide, it falls woefully short of being credible.

Debtor also states that for the remaining 56 months of the Plan, he will generate \$270 a month of net income from "side jobs." In his Declaration, Debtor provides conflicting testimony, stating that he has a part-time job in which his income is actually \$660 a month - 144.44% more than stated under penalty of perjury on Supplemental Schedule I.

On Supplemental Schedule J Debtor lists having two adult children who are "dependents." Debtor does not explain why these two adults are "dependents." On Supplemental Schedule C, Debtor states under penalty of perjury that his food and housekeeping supplies expense for his family unit of

three adults is only \$180.00 a month. Dckt. 36 at 7. This is highly unlikely.

For the five years of the Plan, Debtor and his two adult dependents will have expenses for Personal Care Products and Services of only \$10 a month, clothing and dry cleaning of only \$10 a month, medical of only \$3 a month, entertainment/recreation of \$0.00, transportation of only \$60, and vehicle insurance \$170. For these three adults, Debtor states under penalty of perjury that their monthly expenses are only \$740. *Id.* Debtor's Declaration provides no testimony as to how these three adults - Debtor and his two dependent adult children - actually exist on only \$740 a month.

On his Statement of Financial Affairs Debtor states that he is married. Dckt. 1 at 32. No information is provided about this spouse or the spouse's income. Debtor states in response to Question 4 of the Statement of Financial Affairs that Debtor has not wage, employment, or business income for 2020, 2019, or 2018. *Id.*32.

In response to Question 5 of the Statement of Financial Affairs, Debtor states having the following income from other sources:

SSA.....\$7,250

Rent For Non-Debtor Spouse.....\$2,250

2019

SSA.....\$17,400

2018

SSA.....\$ 1,700

Id. at 33. There is no part-time employment or "side jobs" history of income for the Debtor.

While filing an Amended Plan and Motion to Confirm, it appears that there are substantial deficiencies which counsel knows must be addressed as part of a motion to confirm a plan. There appears to be little reason to just "kick the plan down the road," have the Trustee state opposition to confirmation based on these easily identifiable deficiencies, Debtor then being "surprised" and request a continuance for further delay, and the court allowing the Debtor to delay the prosecution of this case a further ninety days.

The court ordered the case continued to allow Debtor to address the evidentiary and financial issues. While cause exists to dismiss this case, the "corrective effect" of making Debtor and counsel file a new case would result in a financial loss in excess of any "corrective benefit." The court continues this to allow Debtor and counsel a final, final chance to present credible evidence to the court and prosecute the case in good faith.

January 26, 2020 Hearing

For the January 23, 2021 hearing, the court prepared a tentative ruling, but no other supplemental pleadings or documents have been filed.

At the hearing, Debtor requested a continuance so the Debtor could pursue a new plan. The Trustee did not oppose the continuance.

March 3, 2021 Hearing

As of the February 27, 2021 drafting of this pre-hearing disposition, no further pleadings or documents have been filed.

In light of Debtor's delinquency, Counsel's inability to contact Debtor and Debtor's apparent lack of prosecution of the case, cause exists to dismiss this case. The Motion is granted, and the case is dismissed.

The Debtor responds that the modified plan and motion to confirm have already been filed. The Chapter 13 Trustee has agreed to a continuance of the hearing to afford Debtor the opportunity to prosecute the case.

Filing of a Modified Plan

Under the confirmed Plan in this case, Debtor has only \$1,683.00 per month to fund the Plan. Order, Dckt. 19; Plan, Dckt. 13.

In confirming the Plan, the court, Chapter 13 Trustee, creditors, and other parties in interest relied upon the financial information provided by Debtor under penalty of perjury in the amended Schedules I and J filed on February 6, 2018, that there is only \$1,162.00 in projected disposable income. Dckt. 12.

It appears, based on the financial information provided under penalty of perjury, a financial impossibility that Debtor could provide \$8,083.00 in one month to fund the Plan. Or it may be that Debtor has had a change in income due to employment and has yet to file Amended/Supplemental Schedules.

DISCUSSION

Failed to Appear at § 341 Meeting of Creditors

Debtor did not appear at the Meeting of Creditors held pursuant to 11 U.S.C. § 341. Attendance is mandatory. 11 U.S.C. § 343. Failure to appear at the Meeting of Creditors is unreasonable delay that is prejudicial to creditors and is cause to dismiss the case. 11 U.S.C. § 1307(c)(1).

Over Secured Debt Limit

Debtor is over the secured debt limit, disqualifying Debtor from Chapter 13 relief. Pursuant to 11 U.S.C. § 109(e), an individual with regular income who owes, on the date of filing of the petition, “noncontingent, liquidated, secured debts” of less than \$1257,850.00 may be a debtor under Chapter 13. Here, Debtor owes \$1,500,000.00 in secured debt.

Wrong Plan Form Used

Debtor’s Amended Plan is based upon a plan form that is no longer effective now that the court has adopted a new plan form as of November 9, 2018. The Amended Plan is based on a prior plan form, which is a violation of Federal Rule of Bankruptcy Procedure 3015.1 and General Order 17-03. Failure to file a plan on the current form is a delay that is prejudicial to creditors. 11 U.S.C. § 1307(c)(1).

Documents Inaccurate

Debtor may not be able to make plan payments or comply with the Plan under 11 U.S.C. § 1325(a)(6). According to trustee, Debtor failed to fill out the various bankruptcy petition documents correctly. Namely, Trustee argues that Debtor failed to state the business name in her petition, did not list all of her assets in Schedules A/B, failed to file the Spousal Waiver, failed to list the secured claim of Ford Motor Creditor and Ally Bank, failed to list creditor with unsecured claim Capital One Bank; did not answer question #2 in Schedule H, failed to attach Business Income/Expense Statement with Schedule I, and failed to identify dependents on Schedule J where she identifies four dependents on Form 122C-1. Without an accurate picture of Debtor’s financial reality, the court cannot determine whether the Plan is confirmable.

Failure to File Documents Related to Business

Debtor has failed to timely provide Trustee with business documents including:

- A. Questionnaire,
- B. Two years of tax returns,
- C. Six months of profit and loss statements,
- D. Six months of bank account statements, and
- E. Proof of license and insurance or written statement that no such documentation exists.

11 U.S.C. §§ 521(e)(2)(A)(i), 704(a)(3), 1106(a)(3), 1302(b)(1), 1302(c); FED. R. BANKR. P. 4002(b)(2) & (3). Debtor is required to submit those documents and cooperate with Trustee. 11 U.S.C. § 521(a)(3). Without Debtor submitting all required documents, the court and Trustee are unable to determine if the Plan is feasible, viable, or complies with 11 U.S.C. § 1325. That is unreasonable delay that is prejudicial to creditors. 11 U.S.C. § 1307(c)(1).

Pending Motion Seeking Relief Pursuant to 11 U.S.C. § 362(d)(4)

A group of creditors have filed a motion seeking relief from the automatic stay. Dckt. 32. The relief requested includes relief pursuant to 11 U.S.C. § 362(d)(4) and the imposition of a waiver of

the automatic stay automatically being imposed in future cases filed during the next two years.

The Motion does not state with particularity the grounds upon which the 11 U.S.C. § 362(d)(4) relief is requested, but merely states that payments have not been made as set forth in a declaration. The Motion does state that Debtor has had one prior case in the past year which was dismissed for failure to file documents.

The Declaration of Rick Mendoza, an employee of the loan servicer, (Dckt. 35) appears to be stating what would be necessary grounds to be stated in the Motion (Fed. R. Bankr. P. 9013), including: (1) the principal amount of the secured Note is \$1,500,000; (2) there was state court litigation commenced by Debtor which was ultimately settled; (3) extensions of time were granted Debtor to perform the settlement; (4) the first bankruptcy case was filed and the foreclosure sale had to be postponed; (5) the current bankruptcy case was filed four days before the continued foreclosure sale date; and (6) the obligation of \$1,690,709.59 computed by these Creditors as of January 26, 2021, is due in full on March 1, 2021.

In the Motion (p. 3:15-16; Dckt. 32) the value of \$1,500,000 stated by the Debtor on Schedule A/B (Dckt. 1 at 12) is stated. Thus, Debtor would have to provide for paying at least \$1,500,000 over the five years of a plan. *See In re Collier-Abbott*, 616 B.R. 117 (Bankr. E.D. Cal. 2020), discussing the 11 U.S.C. § 506(a) valuation issues when a debt, secured only by a debtor's residence, comes due in full on the terms of the note during the term of a bankruptcy plan. Even if the secured claim was "only" \$1,500,000, the monthly payment over a five year period with a modest interest rate of only 3.5% would be more than \$27,000 a month.

The court shall issue a minute order substantially in the following form holding that:

Findings of Fact and Conclusions of Law are stated in the Civil Minutes for the hearing.

The Motion to Dismiss the Chapter 13 case filed by the Chapter 13 Trustee, David Cusick ("Trustee"), having been presented to the court, and upon review of the pleadings, evidence, arguments of counsel, and good cause appearing,

IT IS ORDERED that the hearing on the Motion to Dismiss is continued to **2:00 p.m. on March 9, 2021**, (specially set day and time) to be heard in conjunction with a creditor's motion seeking relief pursuant to 11 U.S.C. § 362(d)(4).
