**RULINGS**

Each matter on this calendar will have one of three possible designations: No Ruling, Tentative Ruling, or Final Ruling.

Non-appearing parties are advised that the court may adopt a ruling other than that set forth herein without further hearing or notice.

**"Final Ruling"** means that the matter will be resolved in the manner, and for the reasons, indicated below. The matter will not be called; parties and/or counsel need not appear and will not be heard on the matter.

The parties and counsel are advised to recheck the posted rulings after 3:00 p.m. on the next business day prior to the hearing. **ERRORS IN RULINGS**

Clerical errors of an insignificant nature, e.g., nomenclature ("2017 Honda Accord," rather than "2016 Honda Accord"), amounts, ("\$880," not "\$808"), may be corrected in (1) tentative rulings by appearance at the hearing; or (2) final rulings by appropriate ex parte application. Fed. R. Civ. P. 60(a) *incorporated by* Fed. R. Bankr. P. 9024. All other errors, including those occasioned by mistake, inadvertence, surprise, or excusable neglect, must be corrected by noticed motion. Fed. R. Bankr. P. 60(b), *incorporated by* Fed. R. Bankr. P. 9023.

### **Final Ruling**

This court issued an Order to Show Cause for failure to appear at the pretrial conference. Not later than April 19, 2022, the parties were to file opposition. Respondent J. Russell Cunningham did so, and court finds his explanation sufficient. As to attorney Cunningham the Order to Show Cause is discharged, and no sanctions imposed. Respondent Eric Schwab did not file opposition. Because such omissions, e.g., failing to attend the status conference and/or respond to the Order to Show Cause, are not consistent with attorney Schwab's long-standing practice before this court, the court will continue this matter to May 24, 2022, at 1:30 p.m. to allow attorney Schwab to file opposition. Not later than May 10, 2022, Schwab will file opposition to the Order to Show Cause. Failing a good and sufficient reason shown by admissible evidence filed not later than May 10, 2022, the court intends to impose sanctions against attorney Schwab for failing to attend the status conference and will do so without further notice or hearing. The court will issue a civil minute order.
