Debtors respond that they have the means to cure the delinquency and have provided a declaration to that effect.

The court continued the hearing to allow the debtors to make up the delinquency. The court does not currently have evidence that the debtors have come current on plan payments. As a result, cause exists to dismiss the case.

The court shall issue a minute order substantially in the following form holding that:

Findings of Fact and Conclusions of Law are stated in the Civil Minutes for the hearing.

The Motion to Dismiss the Chapter 13 case filed by the Chapter 13 Trustee having been presented to the court, and upon review of the pleadings, evidence, arguments of counsel, and good cause
