Also, if no plan has been confirmed, all proceeds, after payment of claims secured by the subject real property and transactional costs, shall be held by the trustee and distributed pursuant to the plan when confirmed.

See 11 U.S.C. § 521(a)(3). Under these circumstances, attempting to confirm a plan is the epitome of bad faith. See 11 U.S.C. § 1325(a)(3). The failure to appear also is cause for the dismissal of the case. See 11 U.S.C. § 1307(c)(6).

Tentative Ruling: Because this hearing on an objection to the confirmation of the proposed chapter 13 plan and a motion to dismiss the case was set pursuant to the procedure required by Local Bankruptcy Rule 3015-1(c)(4), the debtor was not required to file a written response. If no opposition is offered at the

hearing, the court will take up the merits of the objection. Below is the court's tentative ruling, rendered on the assumption that there will be no opposition. Obviously, if there is opposition, the court may reconsider this tentative ruling.

The objection will be sustained in part and the motion to dismiss the case will be conditionally denied.

The plan's feasibility depends on the debtor successfully prosecuting a motion to value the collateral of GM Financial in order to strip down or strip off its secured claim from its collateral. No such motion has been filed, served, and granted. Absent a successful motion the debtor cannot establish that the plan will pay secured claims in full as required by 11 U.S.C. § 1325(a) (5) (B) or that the plan is feasible as required by 11 U.S.C. § 1325(a) (6). Local Bankruptcy Rule 3015-1(j) provides: "If a proposed plan will reduce or eliminate a secured claim based on the value of its collateral or the avoidability of a lien pursuant to 11 U.S.C. § 522(f), the debtor must file, serve, and set for hearing a valuation motion and/or a lien avoidance motion. The hearing must be concluded before or in conjunction with the confirmation of the plan. If a motion is not filed, or it is unsuccessful, the Court may deny confirmation of the plan."

The court notes that a valuation motion has been filed and set for hearing concerning the collateral of Americredit Financial Services. If the plan incorrectly identifies GM Financial as the secured creditor, then the problem is not the one identified by the trustee. Rather, the plan does not comply with 11 U.S.C. § 1325(a)(5)(B) because it fails to provide for payment in full of the secured claim of Americredit. If the secured creditor is GM Financial, the valuation motion names the wrong respondent.

Because the plan proposed by the debtor is not confirmable, the debtor will be given a further opportunity to confirm a plan. But, if the debtor is unable to confirm a plan within a reasonable period of time, the court concludes that the prejudice to creditors will be substantial and that there will then be cause for dismissal. If the debtor has not confirmed a plan within 75 days, the case will be dismissed on the trustee's ex parte application.

5. 14-29613-A-13 DARRELL DIGGS MOTION TO VALUE COLLATERAL VS. AMERICREDIT FINANCIAL SERVICES, INC. 10-29-14 [23]

Tentative Ruling: Because less than 28 days' notice of the hearing was given by the debtor, this motion is deemed brought pursuant to Local Bankruptcy Rule 9014-1(f)(2). Consequently, the creditors, the trustee, the U.S. Trustee, and any other parties in interest were not required to file a written response or opposition to the motion. If any of these potential respondents appear at the hearing and offers opposition to the motion, the court will set a briefing schedule and a final hearing unless there is no need to develop the record further. If no opposition is offered at the hearing, the court will take up the merits of the motion. Below is the court's tentative ruling, rendered on the assumption that there will be no opposition to the motion. Obviously, if there is opposition, the court may reconsider this tentative ruling.

The valuation motion pursuant to Fed. R. Bankr. P. 3012 and 11 U.S.C. \$ 506(a) will be granted. The motion is accompanied by the debtor's declaration. The debtor is the owner of the subject property. In the debtor's opinion, the subject property had a value of \$8,250 as of the date the petition was filed

and the effective date of the plan. Given the absence of contrary evidence, the debtor's opinion of value is conclusive. See Enewally v. Washington Mutual Bank (In re Enewally), 368 F.3d 1165 (9th Cir. 2004). Therefore, \$8,250 of the respondent's claim is an allowed secured claim. When the respondent is paid \$8,250 and subject to the completion of the plan, its secured claim shall be satisfied in full and the collateral free of the respondent's lien. Provided a timely proof of claim is filed, the remainder of its claim is allowed as a general unsecured claim unless previously paid by the trustee as a secured claim.

OBJECTION TO CONFIRMATION OF PLAN AND MOTION TO DISMISS CASE 10-24-14 [25]

Tentative Ruling: Because this hearing on an objection to the confirmation of the proposed chapter 13 plan and a motion to dismiss the case was set pursuant to the procedure required by Local Bankruptcy Rule 3015-1(c)(4), the debtor was not required to file a written response. If no opposition is offered at the hearing, the court will take up the merits of the objection. Below is the court's tentative ruling, rendered on the assumption that there will be no opposition. Obviously, if there is opposition, the court may reconsider this tentative ruling.

The objection will be sustained in part and the motion to dismiss the case will be conditionally denied.

First, to pay the dividends required by the plan and the rate proposed by it will take 600 months which exceeds the maximum 5-year duration permitted by 11 U.S.C. \S 1322(d).

Second, the plan is not feasible as required by 11 U.S.C. \S 1325(a)(6) because the monthly plan payment of \$143.33 is less than the \$670.21 in dividends and expenses the plan requires the trustee to pay each month.

Third, the plan is incomplete. It fails to state a dividend for Class 7, nonpriority unsecured creditors, whether it may be nothing, 100% or something in between. Without specifying a dividend, the debtor cannot establish that the plan will be feasible.

Fourth, Local Bankruptcy Rule 3015-1(b)(6) provides: "Documents Required by Trustee. The debtor shall provide to the trustee, not later than the fourteen (14) days after the filing of the petition, Form EDC 3-088, Domestic Support Obligation Checklist, or other written notice of the name and address of each person to whom the debtor owes a domestic support obligation together with the name and address of the relevant state child support enforcement agency (see 42 U.S.C. §§ 464 & 466), Form EDC 3-086, Class 1 Checklist, for each Class 1 claim, and Form EDC 3-087, Authorization to Release Information to Trustee Regarding Secured Claims Being Paid By The Trustee." Because the plan includes a class 1 claim, the debtor was required to provide the trustee with a Class 1 checklist. The debtor failed to do so.

Fifth, the debtor has failed to fully and accurately provide all information required by the petition, schedules, and statements. The debtor admitted at the meeting of creditors that she failed to schedule all liabilities. This nondisclosure is a breach of the duty imposed by 11 U.S.C. § 521(a)(1) to truthfully list all required financial information in the bankruptcy documents.

To attempt to confirm a plan while withholding relevant financial information from the trustee is bad faith. See 11 U.S.C. \S 1325(a)(3).

Because the plan proposed by the debtor is not confirmable, the debtor will be given a further opportunity to confirm a plan. But, if the debtor is unable to confirm a plan within a reasonable period of time, the court concludes that the prejudice to creditors will be substantial and that there will then be cause for dismissal. If the debtor has not confirmed a plan within 75 days, the case will be dismissed on the trustee's ex parte application.

7. 14-28542-A-13 NANCY/DANIEL BALAGUY RS-1

MOTION TO CONFIRM PLAN 10-6-14 [20]

Tentative Ruling: The motion will be denied and the objection will be sustained.

First, 11 U.S.C. § 521(e)(2)(B) & (C) requires the court to dismiss a petition if an individual chapter 7 or 13 debtor fails to provide to the case trustee a copy of the debtor's federal income tax return for the most recent tax year ending before the filing of the petition. This return must be produced seven days prior to the date first set for the meeting of creditors. The failure to provide the return to the trustee justifies dismissal and denial of confirmation. In addition to the requirement of section 521(e)(2) that the petition be dismissed, an uncodified provision of the Bankruptcy Abuse Prevention and Consumer Protection Act of 2005 found at section 1228(a) of BAPCPA provides that in chapter 11 and 13 cases the court shall not confirm a plan of an individual debtor unless requested tax documents have been turned over. This has not been done.

Second, Local Bankruptcy Rule 3015-1(b)(6) provides: "Documents Required by Trustee. The debtor shall provide to the trustee, not later than the fourteen (14) days after the filing of the petition, Form EDC 3-088, Domestic Support Obligation Checklist, or other written notice of the name and address of each person to whom the debtor owes a domestic support obligation together with the name and address of the relevant state child support enforcement agency (see 42 U.S.C. §§ 464 & 466), Form EDC 3-086, Class 1 Checklist, for each Class 1 claim, and Form EDC 3-087, Authorization to Release Information to Trustee Regarding Secured Claims Being Paid By The Trustee." Because the plan includes a class 1 claim, the debtor was required to provide the trustee with a Class 1 checklist. The debtor failed to do so.

MOTION TO VALUE COLLATERAL 10-20-14 [14]

VS. FORD MOTOR CREDIT COMPANY, L.L.C.

Tentative Ruling: None. The court will continue the hearing for two reasons. First, the creditor has asked for the opportunity to inspect the vehicle and it will be given that opportunity. Second, the debtor's testimony regarding the cost to repair the vehicle is without foundation and is not admissible. Because the court will continue the hearing, the debtor will be given the opportunity to file admissible evidence.

VS. ARMANDO GARCIA 10-1-14 [28]

Tentative Ruling: The court will abstain from determining the claim objection and will defer to the determination of the state court and the Workers Compensation Appeals Board to determine the debtor's liability to the claimant. The claim is for a personal injury and there are pending court and administrative proceedings. This court does not have subject matter jurisdiction. See 28 U.S.C. § 157(b)(1)(B).

OBJECTION TO CONFIRMATION OF PLAN AND MOTION TO DISMISS CASE 10-28-14 [28]

Tentative Ruling: Because this hearing on an objection to the confirmation of the proposed chapter 13 plan and a motion to dismiss the case was set pursuant to the procedure required by Local Bankruptcy Rule 3015-1(c)(4), the debtor was not required to file a written response. If no opposition is offered at the hearing, the court will take up the merits of the objection. Below is the court's tentative ruling, rendered on the assumption that there will be no opposition. Obviously, if there is opposition, the court may reconsider this tentative ruling.

The objection will be sustained in part and the motion to dismiss the case will be conditionally denied.

First, the plan assumes that the debtor owes no priority tax debt. The IRS has filed a priority claim for \$25,871.29. The failure to provide for payment of this claim violates 11 U.S.C. \$ 1322(a)(2).

Second, with the proposed plan payment and if it is assumed the debtor will pay the priority tax as filed, it will take 76 months to complete the plan. This exceeds the maximum 5-year duration permitted by 11 U.S.C. \$ 1322(d).

Third, the debtor has failed to give the trustee records relating to a worker's compensation suit. Also, the debtor has filed to schedule rental income even though the debtor owns three rental properties. This is a breach of the duties imposed by 11 U.S.C. \S 521(a)(1), (3) & (a)(4). To attempt to confirm a plan while withholding relevant financial information from the trustee is bad faith. See 11 U.S.C. \S 1325(a)(3).

Because the plan proposed by the debtor is not confirmable, the debtor will be given a further opportunity to confirm a plan. But, if the debtor is unable to confirm a plan within a reasonable period of time, the court concludes that the prejudice to creditors will be substantial and that there will then be cause for dismissal. If the debtor has not confirmed a plan within 75 days, the case will be dismissed on the trustee's ex parte application.

11. 14-29066-A-13 ANGELA SMITH JPJ-1

Tentative Ruling: Because this hearing on an objection to the confirmation of the proposed chapter 13 plan and a motion to dismiss the case was set pursuant to the procedure required by Local Bankruptcy Rule 3015-1(c)(4), the debtor was not required to file a written response. If no opposition is offered at the hearing, the court will take up the merits of the objection. Below is the court's tentative ruling, rendered on the assumption that there will be no opposition. Obviously, if there is opposition, the court may reconsider this tentative ruling.

The objection will be sustained in part and the motion to dismiss the case will be conditionally denied.

First, the debtor has failed to make \$1,270 of payments required by the plan. This has resulted in delay that is prejudicial to creditors and suggests that the plan is not feasible. See 11 U.S.C. \$\$ 1307(c)(1) & (c)(4), 1325(a)(6).

Second, the plan fails to provide for the payment of the secure claim of the IRS even though the debtor is retaining its collateral. The plan does not comply with 11 U.S.C. \$ 1325(a)(5)(A) or (B).

Third, The debtor has deducted voluntary pension or retirement plan contributions of \$833.15 a month on Form 22. This is disposable income; the debtor may not make those contributions and deduct them from the debtor's current monthly income. Accord Parks v. Drummond (In re Parks), 475 B.R. 703 (B.A.P. 9^{th} Cir. 2012). As a result, the debtor has monthly projected disposable income of \$812.58. If paid to unsecured creditors, they would share a total of \$48,754.80 over the life of the plan. Because the plan will pay only \$7,615 to these creditors, it does not comply with 11 U.S.C. § 1325(b).

Because the plan proposed by the debtor is not confirmable, the debtor will be given a further opportunity to confirm a plan. But, if the debtor is unable to confirm a plan within a reasonable period of time, the court concludes that the prejudice to creditors will be substantial and that there will then be cause for dismissal. If the debtor has not confirmed a plan within 75 days, the case will be dismissed on the trustee's ex parte application.

12. 14-23467-A-13 MICHAEL/EMMA POST PLG-1

MOTION TO MODIFY PLAN 9-26-14 [29]

Tentative Ruling: The motion will be denied and the objection will be sustained.

First, the debtor has failed to make \$4,588 of payments required by the plan. This has resulted in delay that is prejudicial to creditors and suggests that the plan is not feasible. See 11 U.S.C. \$\$ 1307(c)(1) & (c)(4), 1325(a)(6).

Second, even though 11 U.S.C. \S 1322(b)(2) prevents the proposed plan from modifying a claim secured only by the debtor's home, 11 U.S.C. \S 1322(b)(2) &

(b) (5) permit the plan to provide for the cure of any defaults on such a claim while ongoing installment payments are maintained. The cure of defaults is not limited to the cure of pre-petition defaults. See In re Bellinger, 179 B.R. 220 (Bankr. D. Idaho 1995). The proposed plan, however, does not provide for a cure of the arrearages owed to the Class 1 home loan. Three post-petition monthly payments were not made and the plan will not cure this default. By failing to provide for a cure, the debtor is, in effect, impermissibly modifying a home loan. Also, the failure to cure the default means that the Class 1 secured claim will not be paid in full as required by 11 U.S.C. § 1325(a) (5) (B).

VS. JACQUELINE EPPERSON

OBJECTION TO CLAIM 8-5-14 [38]

□ Trustee Agrees with Ruling

Tentative Ruling: The objection will be sustained in part.

The proof of claim demands \$154,447.29 consisting of \$123,433.12 in unmatured principal and \$31,014.17 in arrears and foreclosure costs. The arrears are based on 32 missed monthly installments of \$885.76.

In this objection, the debtor first maintained that claim should be \$130,519.20 consisting of \$123,433.12 in unmatured principal and \$7,086.08 in arrears (8 monthly payments of \$885.76).

In the claimant's initial response to the objection, she reduced her claim. This included eliminating all demand for arrears predating 2006 and maintaining that 30 monthly payments were not made from 2006 through February 2014. With late fees, this reduced the arrearage demand to \$27,856.92. With these arrears, the foreclosure costs of \$1,303.99, the total claim increased to \$155,315.24.

In the debtor's reply to the claimant's response, the debtor came forward with evidence of additional payments not included in the claimants post-objection accounting. Now the debtor claimed that only 6 monthly payments were missed from 2006 through 2013. This is a total arrearage of \$5,310. However, even assuming this is accurate, the debtor has failed to account for late charges due on the missed monthly installments (\$44.28 per installment or \$354.24 for 8 missed installments), the \$1,303.99 in foreclosure costs, and the two monthly installments that came due in 2014. This makes the arrears \$8,739.75 and when added to the unmatured principal of \$123,433.12, the claim should be \$132,172.87.

In a sur-reply, the claimant conceded that her first response to the objection had omitted the payments referenced in the debtor's reply. But the claimant continues to dispute the debtor's assertion regarding the amount of her claim. According to the claimant, even with the payments accounted for by the debtor, the debtor failed to make 13 pre-petition installment payments not 6 as asserted by the debtor.

The claimant maintains that the debtor failed to make 6 monthly installments in 2009, 5 in 2013, and 2 in 2014 before the petition was filed. As noted above, the objection fails to dispute that 2 payments were not made in 2014. Hence, even if the debtor is otherwise correct, the arrearage consists of 8 monthly installments.

Comparing Exhibit B to Exhibit J, the claimants two attempts to delineate the monthly installments made and not made by the debtor, the court finds two discrepancies. Exhibit B concedes that payments were made March 18, 2009 and on December 5, 2013. But, the second and latest accounting drops any reference to these two payments.

Otherwise, the court concludes that Exhibit J is accurate. It concludes that a total of 11 pre-petition installments were not paid. Therefore the claim includes an arrearage component of:

The failure of the trustee, the U.S. Trustee, creditors, and any other party in interest to file written opposition

at least 14 days prior to the hearing as required by Local Bankruptcy Rule 9014-1(f)(1)(ii) is considered as consent to the granting of the motion. Cf. Ghazali v. Moran, 46 F.3d 52, 53 (9th Cir. 1995). Further, because the court will not materially alter the relief requested by the debtor, an actual hearing is unnecessary. See Boone v. Burk (In re Eliapo), 468 F.3d 592 (9th Cir. 2006). Therefore, the respondents' defaults are entered and the matter will be resolved without oral argument.

The motion for entry of a chapter 13 discharge will be granted.

First, the trustee has filed a final report and the time to file objections to it has expired. His report demonstrates that the debtor has made the payments required by the plan and that the trustee has made the payments to creditors required by the plan. The requirement imposed by 11 U.S.C. \$ 1328(a) that the debtor receive a discharge only after completion of all payments under the plan has been satisfied. See In re Avery, 272 B.R. 718 (Bankr. E.D. Cal. 2002); In re Estrada, 322 B.R. 149 (Bankr. E.D. Cal. 2005).

Second, debtor Robert O'Donnell has filed a certificate in connection with this motion that the debtor is not required by a judicial or administrative order, or by statute, to pay a domestic support obligation. See 11 U.S.C. § 1328(a). No objection has been filed to that certificate and the time to file an objection has expired.

Third, debtor Robert O'Donnell has filed a certificate evidencing that the debtor has completed a post-petition instructional course concerning personal financial management as described in 11 U.S.C. \S 111. This satisfies 11 U.S.C. \S 1328(g)(1).

Fourth, by service of this motion, debtor Robert O'Donnell has given all creditors notice that 11 U.S.C. \S 522(q)(1) is not applicable, and that there is no pending proceeding in which the debtor may be found guilty of a felony of the kind described in section 522(q)(1)(A) or liable for a debt of the kind specified in section 522(q)(1)(B). No creditor has objected to this notice. This satisfies the requirements of 11 U.S.C. \S 1328(h).

Fifth, the debtor has not received a discharge in a chapter 7, 11, or 12 case during the four years preceding the filing of this case nor has the debtor received a chapter 13 discharge in the two years preceding the filing of this case. See 11 U.S.C. \S 1328(f).

Debtor Caroline O'Donnell passed away on December 26, 2012. Nonetheless, prior to her death, she and Robert O'Donnell satisfied all requirements for a discharge except Mrs. O'Donnell did not file a certificate evidencing satisfaction of those requirements. The filing of the certificate is waived.

Therefore, no earlier than 10 days after the hearing on this motion, the clerk shall enter the debtor's discharge. See 11 U.S.C. \S 1328(h).
