Trustee Payments under 11 U.S.C. §330(e)

Trustees will be eligible for additional payments in chapter 7 cases filed between January 12, 2021 and September 30, 2026. As of January 10, 2022, the Administrative Office of the United States Courts has yet to make a determination of the amount to be paid in each case. Our office will make a lump sum payment to chapter 7 trustees who file and are eligible for payments after the deadline to make **a** §330(e) claim has expired.

Which Cases Are Eligible?

- Chapter 7 cases filed on or after January 12, 2021 and on or before September 30, 2026
- Cases filed under chapters 11, 12, or 13 on or after January 12, 2021 and converted to Chapter 7 on or before September 30, 2026.

When Can I Begin Making Docket Entries?

The docket entries will be available for trustee use as of January 10, 2022. This entry can be used for any case in which the trustee is eligible for payment, regardless of fiscal year. For more information on eligibility, trustees should refer to <u>Interim Regulations for Trustee Payments Under 11</u> <u>U.S.C. §330(e)</u>.

How much is the payment for cases filed between January 12, 2021 and September 30, 2021?

The Administrative Office has not yet made a public announcement of the amount that will be paid for each case.

How Long Do I Have to Make My Docket Entries for Fiscal Year 2021?

Trustees will have 90 days from the date of the Administrative Office's public announcement of the amount for each case to make their docket entries.

When Will I Receive Payment?

After the 90-day deadline passes, the court will review docket entries prior to generating payments.

General Information

The Bankruptcy Administration Improvement Act of 2020, which was signed into law on January 12, 2021, establishes a new payment for trustees in Chapter 7 Bankruptcy cases. This payment will be made available to trustees who fulfilled certain requirements in cases that were filed on or after January 12, 2021. It includes cases that are currently closed as well as cases that have been converted from another chapter or converted from another chapter 7.

Requesting Payment by Docketing the Trustee Services Rendered Pursuant to 330(e) Event

To request payment, you <u>must</u> docket the **Trustee Services Rendered Pursuant to 330(e)** event. This event is a "virtual" event, and you will not be prompted to attach a PDF document. However, the event will ask you to indicate how you qualify for the payment by selecting a radio button and linking to the appropriate docket entry. Instructions on docketing this event are included in this documentation.

Other Documents Received re: Trustee Services Rendered

No action will be taken regarding any other documents (such as motions or applications) that are submitted by the trustee to request these funds. To request these funds, the trustee <u>must</u> follow the instructions in this document.

Only One Trustee Services Rendered Pursuant to 330(e) Entry Per Case

Please note that regardless of how many duties you performed that qualify you for this additional payment, you may only make ONE docket entry per case.

Withdrawing the Request

If necessary, you may withdraw the **Trustee Services Rendered Pursuant to 330(e)** event. Like the **Trustee Services Rendered Pursuant to 330(e)** event, the withdrawal event is virtual, and you will not be prompted to attach a PDF.

To withdraw your **Trustee Services Rendered Pursuant to 330(e)** entry, you must docket the withdrawal event. No action will be taken regarding any other documents that are filed with the court to withdraw a **Trustee Services Rendered Pursuant to 330(e)** entry. In addition, any withdrawal must be docketed prior to the payment being processed. Instructions for docketing this event are included in this documentation.
